A WORD FROM THE CHAIRMAN

The board and this office have been quite active during the last few months. Here are a few highlights.

New Storage Unit

First of all, we have moved the storage unit from Harbor City to Buena Park and are now located at 7111 McNeil, just east of Orangethorpe and backing the 91 Freeway. The new location is far more convenient for the majority of the board. We've dropped the monthly rent 18% from \$92 per month to \$75 per month and doubled the size of the unit from 50 square feet to 100 square feet. Most importantly, we've added some new storage shelves that we can use for some new merchandising opportunities.

On Line Store/On Line Merchandise/Resale License

We now have an online store. David Johnson activated it earlier this year. We sold Triple Crown Banquet Tickets initially and will eventually have all of riding events available through on line purchases. And, we'll begin to merchandise general SCMA paraphernalia as well as replacement pins, patches and decals from past Three Flags and other SCMA riding events.

While we aren't formally polling the membership for ideas on what to merchandise, if you have any red hot ideas, then contact one of our board members with the idea.

David Johnson is also working on the resale license for SCMA which is necessary for us to sell retail stuff like we have in mind.

Revitalize District 37 Road Riders?

On March 7, Huey Ward and I attended an exploratory committee meeting to consider re-activating the AMA District 37 Road Riders. We met with representatives of the District 37 Dual Sports Board, PMC board members, ABATE's Riverside Local, and a few other folks to discuss the advisability and practicality of getting the District 37 RR's back and functioning.

I drafted an issue paper that is being circulated to the attendees for comment. SCMA, under my leadership, has been attempting to coordinate calendars and encourage cross-promotion of our affiliated clubs events with an eye toward increasing ridership and membership. These are the principal advantages of regional cooperation. The question that has been imposed by this exploratory meeting is whether an AMA-led initiative would be more effective in promoting road riding in southern California.

The question will remain open for several months. The next meeting of the exploratory committee is set for Monday, May 9th beginning at 6 PM at the Coco's in Arcadia where Michelinda crosses Colorado Blvd and the 210 Freeway. Interested? Then come on by. We'll eat dinner and start the business portion of the meeting at 7 PM.

California Mission Tour

If you haven't noticed, we now are offering the California Mission Tour as well as the California Parks Adventure. Take a look at the newsletter for information. The tour is up and running and, like the California Parks Adventure, has a passport that is designed to record your visits to the 21 Spanish Missions that were constructed from 1769 to 1823 and stretch from San Diego to Sonoma. The missions are beautifully restored. Visiting the 21—and I mean taking time to experience them—will give you a deeper understanding and appreciation for the Spanish and Mexican legacy that influences everything we call "California".

We have Logan and Cheryl Olds to thank for creating this terrific new event. Registration is \$50.

To Piggy-back or not to Piggy-back: That is the Question.

Intrigued with that headline? Well, we're talking about a fairly mundane issue. Should SCMA allow its affiliated clubs to piggy-back on our annual liability insurance policy or not?


Now that SCMA is in its second year of using self-procured insurance, with considerable savings over the rates we received when insured through AMA, should we offer our affiliated clubs to insure through us so that they, too, can save money? It turns out that they can save about \$60 per event if they insure through us. The trouble is, and here's the rub, SCMA would remain the primary insured and our affiliated clubs would simply be named "additionally insureds".

So what's wrong with that? Well, it turns out that SCMA, as the primary insured, would have the primary responsibility for working with the insurance company and the plaintiff if ever there was a significant claim arising from a mishap. The SCMA Board of Directors considered that amount of risk and the hassle to be more than we want to bear and, for this reason, will not be offering this option to our affiliated clubs in the future.

There is one exception. During the middle of our research and before making this final decision, Antelope Valley Riders approached us with a request to insure under us. We preliminarily said yes. Based on that, and wanting to stand by our word, AVR's April 2 Bags for Kids Ride will be insured through us.

But other than this exception, that's it for insurance piggy-backing unless there becomes a way for the clubs to be insured outright and not as an "additionally-insured".



15 Best Roads in 2011

SCMA Chairman Blake Anderson Declares a Challenge: The 15 Best Roads in 2011

SCMA knows about top motorcycling roads and so does AMA. Today, I opened the latest edition of American Motorcyclist and found a very interesting article: "The 15 Best Roads in America, Chosen by You". The AMA has released its pick of the 15 best motorcycling roads, based on a poll of its riders. California has the distinction of having four of its roads in the top 15: CA 58, Angeles Crest Highway, CA 36, and CA 1. We know these roads quite well. In fact, SCMA is quite familiar with most of AMA's top 15 and will, quite coincidentally, be using two of them in this year's Three Flags Classic: OR 3/WA129 and Lolo Pass. Past Three Flags Classics have used all of the Western States roads listed in the top 15. Its only the Midwest and Eastern roads that are outside our grasp.

Well, almost.

All of this gave me an idea for some fun—and a challenge. I know this is a little late, but remember that the AMA article just came out. For those of you completing the USA Four Corners or just wanting to see the west and east coasts in one year, here's your chance to sweep the board by riding all 15 roads during 2011. Let's call this the Chairman's Best Roads Challenge. Take them all on. Prove to me by photos and sales receipts that you've been on all 15 during 2011 and I'll pin a medal on ya'. Well, maybe not a medal, but how about a nifty pin?

Send photos of you and your bike in front of recognizable landmarks for each of AMA's top 15 roads, include a good description of where each photo was taken, and a 2011 time-dated receipt for each of the 15 from a reasonable on-the-route location to: Blake Anderson, SCMA Chairman, PO Box 487, Norwalk, CA 90651. Send me your name, address, phone and email address as well. Get all of this to me by December 15, 2011, and I'll send you a commemorative pin in return. Or, for those of you that intend to show up at the annual SCMA awards banquet in February 2012, I'll hand the pin to you there.

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT (R)

CHARTER NAME, LOCATION, AND SANCTION #

EVENT DATE (S)

IN CONSIDERATION of being permitted to compete, officiate, observe, work for, or participate in any way in the EVENT(S) or being permitted to enter for any purpose any RESTRICTED AREA (defined as any area requiring special authorization, credentials, or permission to enter or any area to which admission by the general public is restricted or prohibited), EACH OF THE UNDERSIGNED, for himself, his personal representatives, heirs, and next of kin:
