## ***BLAZING SADDLES TOUR***

The San Juan Capistrano Mission is not the start location for the Blazing Saddles Tour this year. You will find us off California state route 74 on Rancho Viejo 31722 at Bravo Burgers between 07:00 and 08:00 registering and receiving our riding instructions for the Tour.

Leaving the coast in a fog from San Juan Capistrano we will head up the river valley to Palomar Mountain and Mission Santa Ysabel. Following pie and coffee at Julian we will crest the pass at 4000' and descend into Anza Borrego Desert.

A fuel stop is available north of the Salton Sea at Mecca before entering Box Canyon and Joshua Tree National Park.

Upon leaving the national park we will pass thru Twenty Nine Palms, which is the last gas stop for 120 miles before reaching Kelso Sand Dunes and Baker, California.

North out of Baker we will pass by the Dumont Sand Dunes on the Death Valley Highway to Shoshone, where a short ride on Charley Brown Highway takes us to Pahrump, Nevada for the night.

Leaving Pahrump north to Ash Meadow and Death Valley Junction you will experience a tour of Death Valley, including Death Valley Gateway, Zabriskie Point, Golden Canyon, Furnace Creek Ranch, The Devil's Corn Stalks, and Stovepipe Wells.

Exiting Death Valley over Towne Pass at 5000' is access to Panamint Valley and Searles Lake – Trona. Fuel might be running low as we begin our journey on Hwy 178 to Ridgecrest. Leaving Hwy 178 at Lake Isabella we will venture from Wofford Heights over the 6000' summit in Sequoia National Forest. From there we leave the California highways to Tulare County roads, which place us in the Central Valley.

The shaking town of Coalinga is our exit to the coastal range where we leave gorgeous Priest Valley and head north on the famous California Hwy 25.

Pinnacles National Monument is passed in route to Hollister and San Juan Bautista and the finish of day 2, leaving the Rider the choice of their route home.



## ***Motorcycle Touring Association Update For Wacky Wabbit Wides Again!***

This year MTA CA#3 is trying something a little different. Our National Association of Motorcycle Touring Association headquartered in Virginia is having its annual gathering in Cedar City, UT June 20 - 24 and we want to combine our annual one day Wacky Wabbit Wides Again charity ride with this great event in Utah. So we will use Sunday, June 19 and start in the La Canada/Flintridge area and end on the High Desert near Hesperia. (details to follow) That way we want to encourage as many of you as possible to join us in Cedar City on Monday through Friday. It will only be 350 miles to Cedar City.

This will be the first time our National Association has had its rally so close to Southern California and we want to do everything we can to encourage participation. We're a generic club and everyone is welcome!

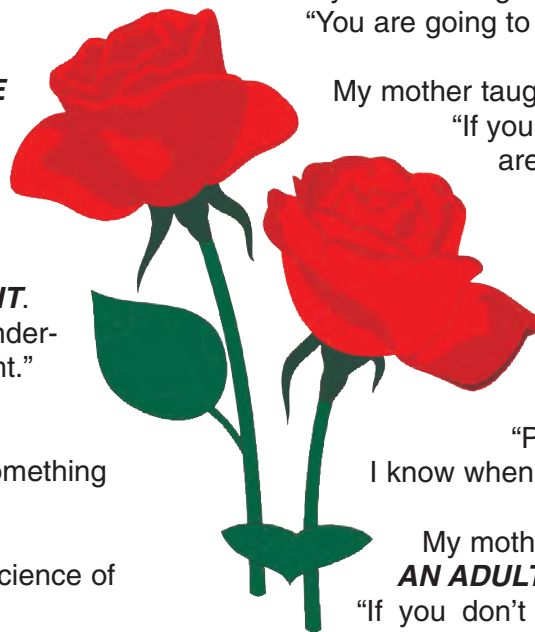

## **FROM THE GUNNY'S SACK**

**HERE WE GO AGAIN FOLKS!** The riding season here in Oregon has officially started with the annual spring motorcycle swap meet in Portland on the 9th of April. I'm just sure now that after all my harping on safety you all have gone through your rides and checked tires, changed oil, checked all the other fluids (if needed), and generally tightened every nut and bolt on your scoot so yer safe this year. Do it now, before ya get into trouble because you're just lazy and would rather ride. Remember brothers and sisters. if yur scoot isn't sound, you could find yourself on the ground. Our venerable AIM attorney Sam Hochberg here can't always fix things if we're doing stupid things.

**MOTORCYCLES CAN RUN RED LIGHTS IN KANSAS. REALLY?** Yes, the Kansas House approved a bill that will allow motorcyclist to run a red light – but only under certain conditions. Called the “Dead Red Bill,” it gives bikers and bicyclists a free pass to go on a red light if the traffic light fails to turn green after a “reasonable period of time.” Many motorcycles are not big enough to trigger the traffic light sensor that determines when a light is supposed to turn green.

The bill is supposed to prevent motorcyclists and bicyclists from being ticketed or fined for running a red light that did not change because of malfunctioning traffic signals or sensors that don't detect bikes. Before the bill, a biker would have to wait until a car came along to trigger the sensor.

This is a law that should be universal across this country, and has been enacted in a few areas. It was attempted and failed in Oregon a few years back. All you lawmakers out there take a good look at this one and bikers all over the place will befriend you.

**DISTRACTED DRIVING WOES:** The Motorcycle Safety Foundation is strongly urging all motorists to stop driving while distracted and backs April's national awareness month to combat this deadly highway hazard. “Distracted driving is of great concern for motorcyclists as we simply have more at stake,” said MSF President Tim Buche. I'll say.

Cell phone use while driving has become a national hazard for everyone on our highways. In Oregon as in many states now there are laws that will getcha a BIG ticket for doing it. Take my word for it folks IT'S AGAINST the law in Oregon and it is a primary stop.

Drive yur car and leave the phone alone or use some device that is hands free to jabber on the talkie. The last thing anyone wants is to be responsible for injury to an innocent bystander because ya just had to gossip. All motorists should be focused on driving.

In 2009, 5,474 people were killed in crashes involving driver distraction (16 percent of the total fatalities). The proportion of fatalities reportedly associated with driver distraction increased from 10 percent in 2005 to 16 percent in 2009. A full 20 percent of injury crashes in 2009 involved reports of distracted driving. - 18% of fatalities in distraction-related crashes involved reports of a cell phone as a distraction. Scooter folks are especially vulnerable to this problem. People don't see motorcycles as it is, and distracted driving makes the road that much more treacherous for us.

Introduced by former U.S. Representative Betsy Markey, the resolution to create a National Distracted Driving Awareness Month was passed by the U.S. House of Representatives in 2010.

Most states currently have laws regulating distracted driving. The US DOT reports that 30 states, the District of Columbia, and Guam ban text messaging for all drivers. Last year alone, 12 of these laws were enacted.



## **THOUGHTS OF A CRABBY OLD MAN**

When an old man died in the geriatric ward of a nursing home in Moosomin, Saskatchewan, it was believed that he had nothing left of any value.

Later, when the nurses were going through his meager possessions, they found this poem. Its quality and content so impressed the staff that copies were made and distributed to every nurse in the hospital. One nurse took her copy to Alberta.

The old man's sole bequest to posterity has since appeared in the Christmas edition of the News Magazine of the St. Louis Association for Mental Health. A slide presentation has also been made based on his simple, but eloquent, poem.

And this little old man, with nothing left to give to the world, is now the author of this 'anonymous' poem winging across the Internet.

 Who dribbles his food and makes no reply.  
 When you say in a loud voice 'I do wish you'd try!  
 Who seems not to notice things that you do.  
 And forever is losing a sock or shoe?  
 Who, resisting or not, lets you do as you  
 will,  
 With bathing and feeding, the long day to  
 fill?  
 Is that what you're thinking? Is that  
 what you see?  
 Then open your eyes nurse, you're  
 not looking at me.  
 I'll tell you who I am as I sit here so still,  
 As I do at your bidding, as I eat at your  
 will.  
 I'm a small child of ten, with a father and  
 mother,  
 Brothers and sisters who love one another.

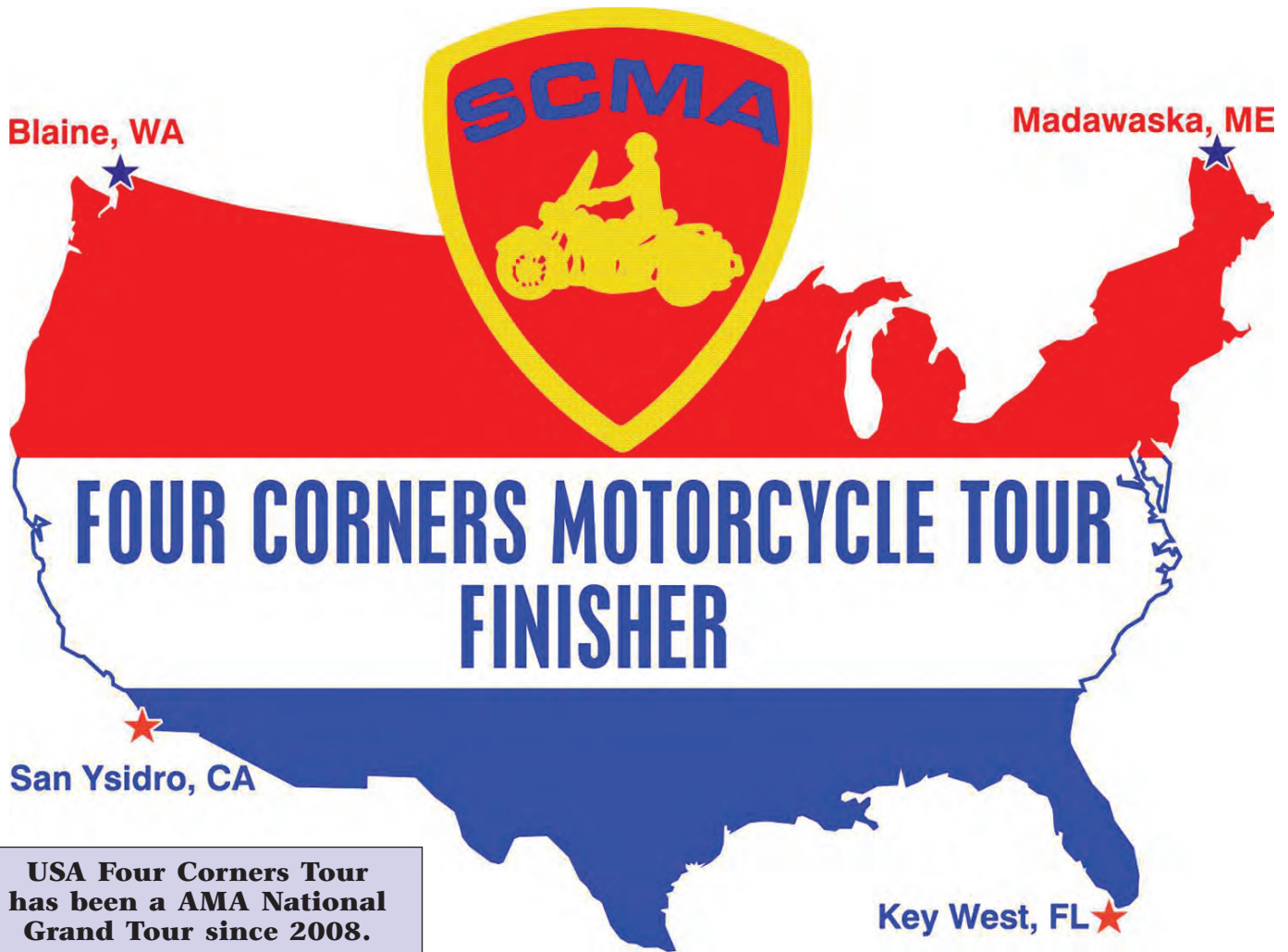
