# **CALIFORNIA ADVENUTRE SERIES Report**

What a year! For many of us riding the 2020 California Adventure Series, our riding was impacted by COVID, lockdowns, fires, riots, extreme heat and a national election. Hopefully we are finished with disasters in California for 2021.

Despite the challenges of riding in California last year, the one positive was the much lighter than normal traffic throughout the state. I rode through the San Francisco area three times this year while riding the Missions, Parks, and CA Best 15. While in the Bay area, it felt like I was in a 1950's "B" Science Fiction movie, as the roads were nearly void of all traffic and minimal people out in public.



With the lighter traffic on the roads, I was able to spend a little more time exploring. One of my favorite stops was at "Radar Station B-71" in Redwoods National Park. The station is just below the Klamath River along a dirt road, to which I had no problem riding on my Goldwing. The radar station was built in 1941 after the attacks on Pearl Harbor. One building was designed to resemble a barn and the other a farmhouse. What an amazing site!

Prior to the Radar Station, I stopped

at the "Douglas Memorial Bridge". This bridge was the last section of US-101 to be built. In December 1964, torrential rains dumped more than two feet of warm rain on the nearby mountains, melting much of the snow. This caused massive flooding of the Klamath River, destroying livestock, farmland, the town of Klamath, as well as the "Douglas Memorial Bridge." Two, eight-ton bear statues still stand at the site of the destroyed bridge.

# California Best 15 Roads

SCMA's CA Adventure Series, a long time favorite amongst the Southwest Region riders and our International and National riders pursuing the Triple Crown, has become an even bigger favorite.

Dennis Even, longtime SCMA member, former SCMA Treasurer, former Chair, CA Adventure Series, and recipient of the Legacy Award, has developed the CA Best 15 roads to ride while you're out visiting Parks and Missions. The Board of Directors reviewed and approved the overall concept and the four groups of roads. The fourth and final set of books listing Series D, the 2021 CA Best 15 Roads, will soon be available.

The concept Dennis and Les Gullery (Shamrock Road Riders) developed consists of 60 fantastic roads in CA broken down to 20 in the North, 20 in the Central, and 20 in the South of California. From that inventory of 60, 15 roads will be selected consisting of 5 each from the North, Central and South areas, to be offered over a four-year period. In years 2018, 2019, 2020, and 2021 a different set of 5 will be selected from the inventory so that at the end of a four-year period riders will have ridden all 60 of these fantastic highways.

A new award titled the CA Triple Crown will be awarded to riders completing all three Adventure Series (Missions, Parks, Best CA15). This award will be similar to the Triple Crown

awarded to finishers of three of premier rides.

Below is the 2021 (Series D) list of CA Best 15 CA Roads you can ride while visiting various parks and missions within California: This is the 4th of 4 sets of 15 CA Best Roads.

All roads can be ridden in either direction, be sure to obtain your gas or store receipt and write your mileage for the start and for the finish.

Sign up now to ride Series D roads in 2021....combine your ride with the Parks and Missions and earn the beautiful California Triple Crown.

# California Triple Crown

We have a new challenge for SCMA members.

A challenge that is completely doable, within reach of everyone, especially members in the southwest region or within a few states close to California.

With the introduction of the California Best 15 Roads, SCMA now has 3 rides with destinations that are often colocated with each other.

The Board of Directors came up with the idea of recognizing those riders who successfully complete the full CA Adventure Series in one calendar year between January 1st and November 30th.

The award very similar to the SCMA Triple Crown and is a beautiful plaque to display in your home.

The **CA Triple Crown** will join the ranks of the other major awards designed to recognize riders that accomplish riding a significant distance in the calendar year.



Those other major awards are the **Triple Crown** award for riding three of the premier events, and the **Premier Grand Slam** for riding all six premier events in a single calendar year.

The **California Triple Crown** is defined as completing the full California Adventure Series in one calendar year. There is one year of eligibility, defined as the year a rider registers for the event, to complete the series and qualify for the California Triple Crown

### **Board of Directors - Nominations for 2021 SCMA Open Positions**

Hello everyone,

As was done last year, due to the impact of the Virus and group meeting constraints, the All Members Meeting required by the SCMA bylaws to be held on the last Saturday of April (4/24), shall be deferred and nominations shall be conducted via USPS mail or via email.

The date of closure of nominations shall be April 23, 2021. The bylaws require 15 days notice before the nomination deadline, and this notice more than meets that requirement.

Below is a definition/description of offices per SCMA By Laws, and the positions that are open for nominations in 2021:

4.03 Designation and Term of Office

There shall be two classes of directors, elected directors and appointed ex officio directors. Elected directors shall be the officers of the corporation, i.e., the chairman, vice chairman, secretary, treasurer, membership services director, and risk manager. The term of office of elected directors shall be two years, commencing July 1, and continuing until their successors are elected and installed. The chairman, secretary and risk manager shall be elected in odd numbered years, and the vice chair, membership services director, and treasurer shall be elected in even years

# **USA Four Corners Tour - First Attempt Failure**

It was some time in 2010 that I was finishing up an assignment in WSMR NM and was heading out the east gate onto Patriot's Highway (US-54), just south of Oro Grande. I was sitting at the stop sign, watching for a break in the southbound traffic, when I spied a long line of Harley Bikers heading north towards Alamogordo.

Watching them rumble by, a little light flashed in my pea-brain. I knew what I wanted to do when I retired next year......I was going to ride a motorcycle all over the USA!

In August of 2011, newly retired, I rolled away from my Orange County CA place of safety with a 14-foot utility trailer loaded with camping gear, clothing, tools, spare tires, and two Harleys – a 2009 Road King and a 1999 Dyna Low Rider.

My first objective was the Sturgis MC rally where I camped out at the Buffalo Chip, spending my days riding the Black Hills and nights listening to rock stars belt it out in the Chip's central arena. At this point, I'm pretty certain I had almost 500 miles of bike riding under my belt!

Then it was off to my brother's place in southern Maryland. The rig was parked and the two of us had been having a good time riding the country roads in southern Maryland. I had spent quite a bit of time planning out a route to ride a big event called the USA Four Corners Tour.....administered by a motorcycle club named the So. CA Motorcycling Association. All I had to do was join the club, send them some money, and they would send me the forms and envelopes to ride the event.

My plan was simple: ride to Madawaska ME, westward across northern USA to Blaine WA, South to San Ysidro, east to Key West, and North back to southern Maryland. Along the way I had this grandiose plan to also ride in every state in the continental USA.

But stuff happens.

.....stuff like Hurricane Irene.

Irene was bearing down on NC and projections were for her to head north along the eastern seaboard. The last thing I wanted was to be out on the road in the middle of a hurricane!

So I hung out at my brother's place waiting for Irene to pass thru MD.....then my plan was to ride north behind the storm.

And then we got hit with the edges of Irene. Trees crashed down, branches broke off, roads were blocked, power was lost, well water was lost due to power loss. Hell, I couldn't even ride out of the neighborhood until roads were cleared.

I spent about another week at my brother's place helping clear trees, etc.

By the time I finally got on the road for Madawaska it was the 3<sup>rd</sup> week of September.

And this is when the fun of learning and gaining experience started.

My plan was to camp as much as possible. Day 1 destination was Aberdeen Army base where they had a campsite available for me....gratis.

As I rode away from the comfort and safety of my brother's place I was full of enthusiasm with the spirit of adventure full upon me. That dimmed a little when I made my first major highway change from MD4 to MD2. There wasn't any signage. I guess because everyone in the area knew the roads.

They weren't expecting an old man from CA with a bag full of AAA state maps. I pulled off to the side of the road to confer with the AAA map and in the process lost my footing in the loose dirt and down went the Road King (Sophia). Oh boy, what a great start!

After righting Sophia and confirming I was on the right road, I continued on towards Aberdeen.

About 50 miles later the first slap with reality hit me. RAIN!!!!

HOLY KWAP !!! WTH !!! Wet stuff, drops, was splattering across my windshield and faceplate. OMG !!! IT NEVER RAINS IN SOUTHER CALIFORNIA!! The tires are going to slip out from under me!!! I better SLOW DOWN !!!

And there I was riding an overloaded Road King 35-40 miles an hour through a very light rain....ok, a sprinkle.

But it was an ominous sign of things to come.

Somehow, via AAA maps, I made it to the campground, at twilight, with barely any time to find a campsite and pitch a tent. Finding a site amongst some trees, I left the bike running and used the headlamp to light up the area of ground that was already quite damp from Irene's generosity. As I began to unload my gear, the kickstand settled into the wet earth and the bike toppled over.

I was being overwhelmed with fun.

As I got her righted for the second time in the day, it started thundering. WTH!!! Are the gods against me on this adventure??? The sprinkling began again.....and more thunder.

That's when I decided, "to hell with camping, let's go to a motel". And am I glad that I did so! As I stepped across the threshold of the motel lobby, with the last of my gear in my arms, the dark sky opened with thunderous flashes of lightening and a pouring deluge began to wash all the mud off *Sophia*.

I hunkered down in my room eating some canned food and washing it down with a beer while looking at the maps. Then the power went out. So I went to sleep.

The morning was bright and sunny as I departed the motel. I don't remember my exact route.....but I think I went thru NYC in the dark, almost being ran off the road by a delivery truck that was in a big hurry to reach a red light. I do remember spending the night in Danbury at a Days Inn. I spent about 20 minutes negotiating with the manager to get the rate down. He finally relented and gave me a 20% discount.....but I still paid too much. What I didn't realize at the time was that the whole area around NYC is VERY expensive.....kinda like living in San Francisco.

I finally made it to Madawaska and spent the rainy night at a motel near the Four Corners Park. The next day at the post office, the clerk totally understood what she had to do with the letter I was mailing to the USA4C Chairman to prove my arrival.

From Madawaska my next stop was the suburbs of Buffalo NY to visit family. I battled rain the whole way to Bangor where I decided to call it quits for the day.....and the next day. I was in the middle of a horrendous rainstorm drenching the northeast.

I remember the morning of the second day standing in the motel lobby watching the rain. Three motorcyclists pulled into the parking lot and came inside to get a room. They had started their day from somewhere in Vermont and after 3 hours of battling the rain and wind they called it quits. Chatting with them a bit, I learned they were from Nova Scotia and were on a weekend trip. Looking out the glass door at their bikes I asked, "What kind of bike are you riding?" "BMW's" was the reply.

"Oh", I said, (pondering the thought that I had never seen a BMW motorcycle and maybe I should go check it out if the rain ever let up). "How's the weather to the east?"

"Miserably windy and hard rain, wait for tomorrow if you're heading that way."

With that they went to their rooms and later, I got to check out their strange looking bikes.....they were not made anything like a Harley. "How can they sit on those things and ride for 2-3 hours", was the thought in my inexperienced and bike-ignorant brain.

I finally made it to N. Tonawanda, but had to ride through rain the whole time. I would often pull into a gas station and wait out the heavier periods of downfall, so it took me three days to get there from Bangor.

One of the first things I did was to buy a new Harley rain suit and waterproof gloves. While visiting the family, I asked if I could use their computer. I had this very original idea of checking out the weather that I would encounter as I headed west. (Wow, what an earth shattering thought coming from a former pilot who used to check weather every day!)

Holy KWAP! The first snow has arrived in Montana! If I'm scared outta my skivvies with riding in rain (and freezing my tail off), it didn't seem to be a good idea to be riding in snow!!

And with that thought, I came to the realization that I had a lot to learn about riding around the country on a motorcycle.

I was 450 miles from my brother's place in MD. I decided to stay a bit longer with the NY family and then return to MD via Williamsport to look at the famous Little League World Series ballpark. I took two days to ride 450 miles and reach southern Maryland.

I took my time. I paid attention to a lot more geographical detail. I reflected quite a bit on what I had experienced in this attempt to ride a huge distance. I reflected upon my lack of riding experience, unawareness of the impact weather has on a motorcyclist, my lack of proper riding gear, challenges of finding motel rooms at 9:00 at night, 1-hour lunches/pit stops and how that lost time would cost me covering 50-70 miles that day.


I reflected on a lot of things and began making plans for 2012. My objective would be to ride out of Orange County on the motorcycle (not trailered) and ride the four corners. I decided to meet more people in the SCMA and find out how to ride.

# Announcing the 2021 Collection Best 15 US Roads Challenge

With the travel and lodging restrictions that we all faced in 2020, only three SCMA riders were able to complete the Challenge. For 2020, the road list had been refreshed with eight replacement roads to entice members to take the Challenge. Few were certified finishers of that new list, so it is again being offered as the 2021 Challenge list.



As stated in the best 15 US roads Challenge Rules, a registrant will have a two year window to complete the Challenge, however, ALL roads must be ridden in one calendar year between January 1th and November 15<sup>th</sup> with ride logs submitted by November 30<sup>th</sup>. There is a one time exception for that rule for the 2020 registrants because of the "beyond our control" travel restrictions. Those registrants can carry over roads ridden in 2020, then ride the remaining roads on the list to finish in 2021.

There are 16 roads on the Best 15 list, BUT, the registrant can eliminate the road of his or her choice to become a finisher. The reason for 16 roads was to give riders not also doing a Four Corners Tour, options on their ride planning.

Best 15 US Roads Challenge registrants will receive a packet containing a Best 15 t-shirt, and a Best 15 pin and patch. Finishers will also receive an engraved Buck 112 Ranger Knife and a "suitable for framing" certificate to commemorate their accomplishment!!

Because of the road closure on CA1, as stated in the rules, a rider may start at either end, proceed to the road closed sign, and take the required photo to complete the road requirement. OR, as an alternative, a rider may choose to ride CA70 between Oroville and Quincy.

There are Sixteen roads listed, but only FIFTEEN are required to be a Challenge finisher, the registrant can eliminate any ONE of the 16 roads offered.

\*NOT required, but at the junction of NM-35/NM-15 take NM-15 NORTH for 18 miles to the Gila Cliff Dwelling Nat Monument as a point of interest. Spur adds 36 miles

As fast as it came up, it went down.


Disappointing, as you would expect, when something just goes away.


# 44 Years of 3FC Routes


# Ports of Entry to Mexicali



# Three Flags Classic - Ticket Resales

Each year, before the start of a 3FC, approximately 10% of 3FC Ticket Buyers find that they are unable to attend and try to sell their ticket to a buyer.

Since 2016, the 3FC Chairs have been burdened with tracking ticket resales and ensuring SWAG bags are renamed/renumbered, etc. Database corrections and updates became a struggle, as was the collection of stats for Les Gullery to report the numbers of riders, states, countries, bike models, etc.

During the 2019 registration process, we stumbled upon a process that simplified the collection of data and ensures transaction integrity. Riders purchasing a resale ticket are assured they will receive their SWAG, pre-printed passport, and proper sized t-shirt. Sellers can also be assured of receiving their full payment as the resale price remains fixed to the original purchase price.

Here is the resale process that will be followed during 3FC21.

- 1. SCMA will establish a "3FC21 Ticket Re-sale" page on the forum or somewhere easily accessible by members.
- 2. Upon deciding to sell a 3FC ticket, seller would go to this webpage and list their name(s), quantity of tickets, contact information.
- 3. Buyers can be recruited by individual sellers or can simply go to the website and contact a seller.
- 4. Re-sales will be made in the date-order of listings; exception to this rule will be if a seller brought his/her own buyer to the deal.
- 5. Seller then contacts the designated administrator (eg. Gonzo at 949xxxx or Filley at 619xxxx) and informs the administrator that he is selling a ticket to "Buyer Name"
- 6. Buyer calls Administrator to report he is buying such ticket from (Seller Name).
- 7. Buyer goes online and purchases a new ticket.
- 8. Administrator removes the seller from the data records and informs treasurer to repay seller.
- 9. Repayment will either be via PayPal or a check from SCMA (in event seller purchased ticket more than 6 months prior to resale).
- 10. Transaction fees incurred by SCMA will be deducted from the refunded amount.

We certainly hope that all registrants for 3FC21 will be able to make it to the start
